I, SPEROS CONDOS, of the City of Stamford, County of Fairfield and State of Connecticut, being of sound and disposing mind and memory, do make, publish and declare this to be my Last Will and Testament, hereby revoking all wills and codicils heretofore made by me.

ARTICLE I. I direct that all of my just debts, (except debts secured by any mortgage on real estate) my funeral expenses and the costs of administration of my estate be paid as soon as practicable after my death. In her sole discretion, my Executor may pay from my domiciliary estate all or any portion of the costs of ancillary administration and similar proceedings in other jurisdictions.

ARTICLE II. I direct that there shall be paid out of that portion of my residuary estate which is not included in the share qualifying for the marital deduction, without apportionment, all estate, inheritance and like taxes (together with any interest or penalty thereon), imposed by the government of the United States, or any state or territory thereof, or by any foreign government or political subdivision thereof, in respect of all property required to be included in my gross estate for estate or like tax purposes (except generation skipping taxes on other than direct skips) by any of such governments, whether the property passes under this will or otherwise, including property over which I have a taxable power of appointment, without contribution by any recipient of any such property. For the purposes of this Article, the term "estate, inheritance and like taxes" shall exclude the taxes on qualified terminable interest property.

ARTICLE III. All the rest, residue and remainder of my property and estate, real and personal, of whatever nature and wherever situated, including any property hereinbefore mentioned but not effectually disposed of (but excluding any property over which I may have a power of appointment, it being my intention not to exercise any such power), I direct my Executor to liquidate

as soon as practical after my death and to distribute the proceeds to the following people, in equal shares, per stirpes: (a) my cousin, LULU SALAMAS of Oakley, California; (b) my cousin, EFSTRATIOS CHOCAS of The Villages, Florida; (c) my cousin, HELEN RUDOMANSKI of Columbia, Maryland; (d) my friend, MARY POCCIA of Stamford, Connecticut; (e) my friend, FRANK POCCIA, SR. of Stamford, Connecticut; (f) my cousin, KIKI HERBERT of Stamford, Connecticut; (g) my cousin, CLEMENTINE GRIMALDI of Northridge, California; (h) my grandnephew, JAMES YERKES, JR. of New York; (i) my grandniece, COLLEEN HAYES of Stamford, Connecticut; and (j) my home health aide, ELIZABETH EDDY of Bronx, New York.

ARTICLE IV. If any individual shall be under twenty-one years of age at the time he or she becomes entitled to a distribution under the terms of this my last will and testament, the share of such individual shall be retained in trust by the Trustee until he or she attains such age. During such time, the Trustee shall pay to such individual or expend on his or her behalf so much of the net income derived from his or her particular fund and so much of the principal thereof as the Trustee may deem advisable to provide properly for the maintenance, support and education of such individual, and may incorporate any income not so disbursed into the principal of the fund. When each such individual shall attain the age of twenty-one years, or shall die before attaining that age, the trust shall terminate as to such individual, and the Trustee shall distribute his or her fund to such individual in fee or to the estate of said individual if such individual has died before attaining the age of twenty-one years.

ARTICLE V. I nominate, constitute and appoint JAMES M. RUBINO of Stamford, Connecticut as the Executor of this my Will and Trustee of any trust or power in trust established hereunder. If the said James M. Rubino shall fail to survive me, fail to qualify or cease to act, then in such event, I nominate, constitute and appoint FRANK POCCIA, SR. of Stamford, Connecticut

as my Successor Executor and Successor Trustee to act in his place and stead. To the extent I have the power to do so, I direct that no probate bond or similar undertaking shall be required of any fiduciary appointed by me, acting in either capacity, in any jurisdiction in which he or she may be required to act.

ARTICLE VI. I authorize and empower my Executor and my Trustee and any substitute or successor fiduciary, in addition to other powers granted by law, to exercise all those powers set forth in "Fiduciary Powers Act" of the State of Connecticut as the same provides as of the date of the execution of this will.

ARTICLE VII. The use of the masculine gender in this my Will shall be deemed to include the feminine (or corporate entity) and the singular the plural we the context would so require.
