IN THE MATTER OF THE ADMINISTRATION OF THE
GOODS, CHATTELS AND CREDITS OF

Maria Jerks

DECEASED.

TO THE SURROGATE'S COURT OF THE COUNTY OF WESTCHESTER:

THE PETITION of *Moses Jerks*
of the Town of *Mount Pleasant* in the said County of Westchester,
respectfully sheweth:—

That *He* is a Son
of *Maria Jerks* late of the Town of *Mount Pleasant*
in the said County, deceased; that the said *Maria Jerks*
departed this life in the Town of *Mount Pleasant* in said County, on
or about the *Ninty* day of *April* one thousand eight
hundred and *Ninty four* INTTESTATE, as your Petitioner verily believes; that your Petitioner
has made diligent search and inquiry for a Will of the said deceased, and has not found any, or obtained
any information that *She* left or ever made one.

That your Petitioner has, to the best of *his* ability, estimated and ascertained the value of the Per-
sonal Property of which the said deceased died possessed, and that the same does not exceed in value the
sum of *One Hundred (\$100.00)* Dollars. *And the value*
of *her* real estate was *nothing at all*, she having left none

a Grand daughter of the deceased who resides in
the City, County and State of *New York.*
- And all of the above mentioned heirs and next of kin

are over the age of Twenty one Years
And Abraham D. Parks who is a Grandson of the
deceased who resides in the City. County and State of
New York who is Nineteen Years old
And Mary C. Parks who is a Grand daughter of the
deceased who resides at South Tarrytown County of Westchester
A. C. who is 15 Years old

Your Petitioner further shows that the said intestate, at or immediately previous to her
death was an inhabitant of the said County of Westchester; that your Petitioner is of full age; that he
is informed and believes that the Surrogate of the County of Westchester has sole and exclusive power to
grant **LETTERS OF ADMINISTRATION** of the Goods, Chattels and Credits of the said intestate,
and prays that all persons above named having a prior or equal right with your Petitioner may be cited to
show cause why a decree shall not be made granting such Letters to *Said Petitioner*.
